Central Texas Veteran Services Coalition Meeting Minutes July 21, 2016

- I. Welcome and Brief Introductions of VSOs
- II. VSO Partner Spotlights
 - a. Jennifer Cerretti, Program Manager with Goodwill told us about Operation Good Jobs which starts with a centralized intake through phone or email where clients are screened for eligibility. One on One case management services are provided. They want to see the client from start to finish with finish being employment. Contact is made with a case manager monthly for 12 months for retention and to keep them employed.

Support services include help with utilities, car repair and transportation.

Technical Academy training includes CDL and other programs based on eligibility including income requirements (less than 200% poverty) and residency (Austin or Travis County). **These requirements are for employment programs that funding is leveraged from. The vet program has no income requirement.

The veteran requirements are NO dishonorable discharge and at least one day service. The funder for the program has a focus on OEF/OIF/OND but all vets accepted.

b. Preston Petty, ECHO Coordinated Assessment Program Director. They are the lead agency for the Travis County Continuum of Care, a HUD designation. They cover Travis, Bastrop and some Williamson County. Overview of Coordinated Assessment – when a veteran experiences homelessness he or she can go to ONE place – either call the intake line or go to Salvation Army or Front Steps. Our responsibility as a community is to share info and identify services. ECHO workers will go physically into the woods. Their biggest partners are the SSVF programs at Front Steps, Caritas, and the VA Housing Program. They can get a vet housed within 90 days from point of contact. The PIT Count in 2015 was 234.

Q: Does a voucher just pay for rent or does it include utilities? A: If the unit is not All Bills Paid then there is a supplement for utilities.

Preston gave 2 examples of rehousing.

c. Rvan Burke, Front Steps SSVF

Who is eligible? Vets experiencing literal homelessness. If you have somewhere to stay you are not qualified.

Vet qualifications are to have served at least 1 day of active service and NO dishonorable discharge.

Income qualifications – If earn less than 50% of area median income then qualify for 6 months of assistance. If 30% below then 9 months assistance.

Case managers will walk a client through the process.

Q: How fast is the process?

A: The Continuum of Care meeting is Monday. They take the referrals and make phone calls to contact the vets the next day. Intake is scheduled for that week. Then a plan is created with their case manager. If the veteran is engaged in the process it can happen within days.

Q: How does it work for a vet without a phone?

A: They will go out and find them in their regular hangout spots.

The group ran through some scenarios with different veteran profiles.

a. Austin Furniture Bank Update

They are officially a 501(c)3

Board meetings are being held once a week at this point to get the non- profit established.

Q: Are board meetings open to the public?

A: Not sure.

A new policy is in place- \$70 delivery fee. So far they have delivered to over 100 homes at no cost. They have gotten truck and crew donations from local moving companies. But they want to be self sustaining. And the warehouse will start charging rent soon. Will start having fundraisers soon to generate revenue. They would like to employ Bo since he has been working so hard for free.

They have been in communication with furniture banks all over the country.

Opened a bank account a week ago.

It is going really well and developing quickly.
